### PREVENTION:

### RESPONSE:

**If skin irritation or rash occurs:** Get medical advice/attention. Specific treatment (see First aid measures on this label).

**In case of fire:** Use carbon dioxide (CO2), dry extinguishing powder, foam to extinguish.

### STORAGE:

Store in a well-ventilated place. Keep cool. Store locked up.

### DISPOSAL:

Dispose of contents/container to comply with local/regional/national/international regulations.

### DIRECTIONS:

Attach the trigger sprayer and adjust to a fine mist. Spray into the center and corners of room. Avoid spraying directly onto plastic surfaces. For extended odor control, moisten the granules in scent cup with 6 to 12 pumps of sprayer (or pour directly from can) and place in the room where air currents will carry scent.
